Teri Eyre, PhD, Member, Executive Compensation Committee

Teri Eyre is an accomplished Human Resources executive and board member with a record of creating shareholder value through human capital strategies that drive growth, performance, and scale. Teri had a distinguished career at Hewlett-Packard Company where she led global HR for multiple business sectors. A Senior Vice President of the company, Teri was accountable for a workforce of more than 115,000 employees in 50 countries. An influential business leader, Teri contributes adeptly on a range of strategic and operational matters, extending beyond the typical purview of human resources.

Currently an advisor to C-suite executives and Boards, Teri brings a unique set of skills honed through senior executive roles and expertise with board-relevant topics including executive succession, compensation, governance, and business transformation. He began his corporate career as Vice President of Personnel for Frito-Lay, a \$3 billion, 26,000 employees, a division of PepsiCo. He also founded and managed Personnel Development Inc., a management consulting firm specializing in organizational/individual assessment and development.
